## 1. Background to CATHSSETA

### VISION STATEMENT

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SPP) supported by skills development programmes serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity.

CATHSSETA’s critical success factors are described as the Key processes that deliver services to the CATHSSETA beneficiaries, i.e. learners and employers. The process is based on the three critical components of the CATHSSETA service delivery Value Chain:

- Facilitation of Learning Interventions. Involves facilitation of all skills development initiatives
- Quality Assurance of Skills Development. Involves accreditation of skills development facilitators, verification of learners, and development of occupational qualifications
- Employer engagements. Involves the receipt of levies and payments of grants.

The importance of the three areas are the points of integration between them.

CATHSSETA seeks services of an independent service provider to ensure that the process is fair, transparent, credible and objective. The role of the service provider will include:

- Evaluate mandatory and discretionary grants applications,
- Conduct Site visits
- Project management of contracts from 2013-2015 learning programmes,

- Manage industry funded learning programmes

<b>A. Evaluation of applications for Mandatory and Discretionary Grants:</b>
--

The SETA Grant Regulations requires SETAS to allocate Mandatory Grant to levy paying employers that has met certain criteria and requirements set by a SETA”.

The regulations further allows for SETAs to prepare and distribute grant application and project proposal forms in a manner that enables opportunities for a legal person or enterprise of different sizes (including small and micro enterprise, NGOs and Cooperatives in sector to apply for Discretionary Grants to benefit

To ensure compliance with the Grant regulation, CATHSSETA evaluates mandatory and Discretionary grant to ensure that implementation runs smoothly with no complications.

Compliance checks and evaluation will be done through an online tool in order to increase efficiency. A minimum of 3 windows(1x window for Mandatory and 2x windows for Discretionary Grants) will be opened per annum. An estimate number of 2 300 for mandatory and discretionary grant applications are received from all provinces. Evaluation process will include but not limited to the below:

- Evaluate applications for pivotal programmes in line with approved criteria and the approved Discretionary Grant Policy
- Maintain a clear and unambiguous record of evaluation proceedings
- Evaluate Mandatory grants application in line with approved criteria and approved policy.
- The scope for evaluations of mandatory grants include actual evaluation of all submissions/ applications, review of request for extensions, appeals as well as conducting site visits in compliance with policy requirements
- Conduct due diligence visits for discretionary grants and produce reports for each case.
- Compile and submit evaluation reports with recommendations and support processes for consideration and decision making purposes by relevant structures within CATHSSETA

### **B. Project management of contracts from 2013-2015 learning programmes.**

CATHSSETA has during the previous years disbursed Discretionary Grants programmes for both employed and unemployed to address forecast of scarce and critical skills identified. Full-value chain project management, monitoring and evaluation forms a continuous and integral part of ensuring that projects are well implemented, controlled and closed. There are approximately 122 live contracts emanating from 2013-2015 that needs to be managed and closed. Duties related includes:

- Conduct a diagnosis and analysis of old projects, and provide recommendations for decision making purposes.
- Liaise with the service providers and employers for continuous feedback and information dissemination for administrative processes per project,
- Track, manage and mitigate risks throughout the remaining project life cycle.
- Ensure a proper integration of organisational documents to be used for each project implementation (payments, reporting, filing and monitoring)
- Administer all contractual payments and ensure that they are in line with the tranche payment schedule and ensure payment of service providers is in line with the approved contract and agreed time lines.
- Submit all project files to the central filing system and archive all project data
- Compile and submit monthly progress reports including recommendations for each project attended to every month
- Complete contract close out report and close out the contract on the commitment register
- Manage stakeholder relations

### **C. Management of the CATHSSETA records management process**

CATHSSETA learning programmes Information is a central strategic objective. CATHSSETA is required to adequately document and preserve Learning programmes information for audit purposes. Duties related will include:

- Creating Records, including the early capturing of records in order to provide adequate and proper documentation of CATHSSETA learning programmes activities. This will be achieved by complying with record keeping requirements established by CATHSSETA records management policy.
- Using and maintaining records which includes document control; files and filing equipment must be maintained in an approved requirements of CATHSSETA document management Policy
- Ensure that Learning Programmes documents are accessible to others and easy to retrieve for all CATHSSETA audit requirements.
- Coordinates transfers of records for archiving
- Classification of records per learning programmes intervention
- Manage internal stakeholder relations
- Produce monthly records management reports and close out report at the end of the project.

### **D. Support the Administration of Industry Funded Learning Projects**

NSDS III puts emphasis on the need to train employed workers to improve the overall productivity of the economy and address skills imbalances. CATHSSETA as a training authority for its specific sub sectors manages the registration and document management of industry funded learning projects. Industry funded learning projects are learnership and skills programmes that are being implemented and funded by the industry and not CATHSSETA. Employers and training providers declare interest to provide their employees with learnerships and skills programmes on quarterly basis nationally. This process requires CATHSSETA to manage the registration process and

ensure that documents are filed and archived for certification and audit purposes. Duties aligned to management of industry funded learning programmes include:

- On entry of all industry funded learners, conduct visits to training providers and collect all information for industry funded.
- Validate performance information before reporting of learning either on entry and completion of both industry and seta funded learners.
- Support and assist the SETA in conducting induction, M&E and site visits
- Liaise with the service provider and employers for continuous feedback and information dissemination.
- Register learners on the CATHSSETA management system upon receiving prescribed documentation (signed learner agreements, recently certified ID copies, CV and results)
- Manage CATHSSETA Quarterly Monitoring Report, upload and conduct monthly QMR audit.
- Submit all project files onto the central filing system and archive all project data.
- Compile and submit monthly progress reports including recommendations for each project attended to every month
- Manage printing of certificates and ensure that they are disseminated to the employers and training providers.
- Manage stakeholder relations

If any clarity needs to be obtained for evaluation purposes CATHSSETA may require the potential service provider to substantiate certain information, or to allow officials to undertake a financial/ physical inspection to assure that capacity and ability is proven.

Post contract (Regulation 11.9)

- (9) A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the sub-contract.

Regarding joint ventures, the joint venture agreement between the different suppliers must be provided clearly indicating the role and responsibilities of each supplier towards the contract.

## TAX CLEARANCE CERTIFICATE REQUIREMENTS

## DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT

This Standard Bidding Document (SBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).
