1. Background to CATHSSETA

VISION STATEMENT

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SPP) supported by skills development programmes serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity.

CATHSSETA as a Sector Education Training Authority, has a mandate to develop relevant and current Qualifications for the sectors that fall within its scope. This has to be done in partnership with the QCTO, SAQA, Professional Bodies and Industry in the process of developing Occupational Qualifications and also to identify Qualifications that have to be phased out taking into account CATHSSETA's scarce and critical skills. The QCTO is currently considering de-registering all non-active Qualifications across SETAs which may be replaced by new Occupational Qualifications.

Current historical qualification must be *realigned* to the QCTO occupational qualification. The realignment process subject current legacy qualification to a conversion process into QCTO occupational qualification. The following historically registered qualification will be evaluated, mapped against existing OFO codes and a determination made in consultation with stakeholders about the most critical 6 priority occupational qualifications:

- National Certificate: Food and Beverages (ID: 14111)
- FETC: Live Event Technical Production (ID: 48669)
- National Certificate: Nature Conservation Resource Guardianship (ID: 59389)
- National Certificate: Gaming Operations (ID: 63269)
- National Certificate: Coaching Science (ID: 64369), and
- FETC: Sport Coaching – Juniors and Beginners (ID: 67695)

This initiative is aimed at ensuring that the Occupational Qualifications Sub Frame (OQSF) is populated with Occupational Qualifications as envisaged in the Minister's Determination on the three sub- frameworks.

CATHSSETA seeks services of a independent service provider to realign and convert historically registered qualifications into Occupational Qualifications before current registration end date

6. Detailed scope of services to be rendered by the service provider

1. Conduct an analysis on the current CATHSSETA legacy qualifications and determine occupations aligned to this qualifications and their Occupations Framework for Organisations (OFO) codes. Map historical qualifications against the current OFO codes and associated occupational qualifications. Workshop the outcome with industry stakeholders to determine the **6** critical occupational qualifications for realignment after CATHSSETA approval. Produce a comprehensive report with findings and recommendations.
2. Develop and submit a project plan for realignment of the **6** identified qualifications after consultation with relevant stakeholders
3. Undertake qualification realignment processes in compliance with the QCTO guidelines for occupational qualifications framework
4. Coordinate and manage public inputs into the qualification development processes.
5. Submit the drafts of **6** realigned qualification for consideration and evaluation
6. Develop and present the QCTO Progress and Process Reports to CATHSSETA as the Development Quality Partner (DQP).
7. Capture all qualifications in the QCTO system
8. Compile and submit Project Closeout Report in collaboration with CATHSSETA as the DQP

If the suggested changes are unacceptable the General conditions of contract and the special conditions of contract will stand. The potential bidder will then have to decide to abide by the decision or to withdraw its bid proposal.

If any clarity needs to be obtained for evaluation purposes CATHSSETA may require the potential service provider to substantiate certain information, or to allow officials to undertake a financial/physical inspection to assure that capacity and ability is proven.

Supporting documentation should be attached as annexures and cross-referenced to the appropriate section of the bid.

Please note that the scope of services as indicated in this TOR reflects CATHSSETA true requirements and once the contract is signed amendments to the contract will only be allowed in exceptional circumstances. Please ensure that your costing is based on the scope of services to be rendered.

Disclaimer

Post contract (Regulation 11.9)

- (9) A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the sub-contract.

Regarding joint ventures the joint venture agreement between the different suppliers must be provided clearly indicating the role and responsibilities of each supplier towards the contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
