1. Background to CATHSSETA

VISION STATEMENT

“A Leader in skills development within our diverse sector”

MISSION STATEMENT

“To facilitate skills development through strategic partnerships for CATHSSETA to contribute to economic growth”

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SPP) supported by skills development programmes serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity.

CATHSSETA’s critical success factors are described as the Key processes that deliver services to the CATHSSETA beneficiaries, i.e. learners and employers. The process is based on the three critical components of the CATHSSETA service delivery Value Chain:

- Facilitation of Learning Interventions. Involves facilitation of all skills development initiatives
- Quality Assurance of Skills Development. Involves accreditation of skills development facilitators, verification of learners, and development of occupational qualifications
- Employer engagements. Involves the receipt of levies and payments of grants.

The importance of the three areas are the points of integration between them.

Problem statement

CATHSSETA over the years has been implementing different learning programmes with different learning institutions, both public and private. CATHSSETA however has not developed a mechanism or an instrument to track beneficiaries of these programmes for impact and assistance with associated opportunities. For example, some beneficiaries may be required to enrol further for integrated work placement programme. Equally impact will require CATHSSETA continually assess if beneficiaries are gainfully employed post the learning programmes. As a result the SETA does not have a credible data source that can be used to determine the skills set of trained beneficiaries(employed and unemployed) in

the sector. To assess delivery efficacy, CATHSSETA need to track the number of learners on a yearly basis competing TVET qualifications.

It is therefore critical that the SETA develop a web-based instrument to track the learners who have benefitted from SETA funded programmes (probably even those not financed by CATHSSETA in the long term). The functional instrument will draw from the current incomplete CATHSSETA database, contacting private providers (accredited by CATHSSETA) and SETA funded learners who have completed qualification from TVET Colleges.

A web based instrument should enable learner data to be captured remotely by all private and public providers and verified by CATHSSETA. Employers should also be able to access a portion of the database remotely to select learners for Workplace Integrated Learning programmes. Additionally, the service provider will be required to clean up the current database/portal by verifying and updating details of learners. A large database of employers working with CATHSSETA is also available for enhancement and verification.

2. Overall objective

CATHSSETA seeks services of service provider to track beneficiaries who have benefitted from CATHSSETA projects from 2014/15-2015/16, 2016/17 financial year to establish whether they have been gainfully employed post the learning programmes. CATHSSETA is particularly seeking for providers who will use innovation

The scope of the project will be to:

- Develop database of learners who have successfully completed programmes from 2014/15 to 2016/17 financial years
- Clean up database of collected
- Track and trace learners who have completed learning programmes
- Capacity building for CATHSSETA staff
- Maintenance of the tracking system
- Management of handover processes

6. Detailed scope of services to be rendered by the service provider

A. Develop database of learners who have successfully completed programmes from 2014/15 to 2016/17 financial years

CATHSSETA through the NSDS III is mandated to implement learning programmes in order to upskill both employed and unemployed learners within the 6 CATHSSETA subsectors. On an annual basis CATHSSETA funds learners who participate in skills programmes, learnerships, internships, work integrated learning and bursaries. It is critical for CATHSSETA to track and trace the learners in order to establish if there has been value add to the participants post the learning interventions. CATHSSETA therefore needs to determine the return on investment of all learning programmes implemented.

Service of independent provider is therefore needed to track all funded learners from the years 2014/15, 2015/16 and 2016/17. A secure web based system must be developed to track learners who have successfully completed all learning programmes. The first step is to establish a secure web based system which will be used as a tracking tool. The secure web based system will be managed by CATHSSETA and made available to all sector employers.

The web based system will further be used as database that the sector can use to access skilled and capable people for recruitment and placement purposes. The web based system will be updated as and when the status of the learners are placed in employed or business.

B. Clean up database of collected learner information

CATHSSETA is custodian of information for all learners who have enrolled and completed learning programmes. The prospective service provider will be required to conduct an analysis to determine how many learners who have enrolled in learning programmes have successfully completed, update the learner information and verify learners qualification and credentials. The database must be current and up to date and enable the CATHSSETA sectors to access information of learners for placement purposes. The service provider from time to time will be required to engage with employers and training providers (mostly TVETs) nationally. The clean up of the database will include updating and capturing of information obtained from the engagements.

C. Track and trace learners who have completed learning programmes

The service providers will also be required to track learners who have benefitted from the programmes by directly contacting learners or their employers. Learners must be traced to determine if they are employed or unemployed, the tracing model must be able to determine which learners are employed within or outside of the sector, update information of learners on annual basis. For employed learners the tracing study should be able to determine if the learners job status have changed i.e determine if the learners have been promoted or obtained a better job elsewhere. The service provider will be required to update the secure web based system during and after the tracking. CATHSSETA learners are located in all 9 provinces of South Africa.

D. Maintenance of the tracking system

Upon completion of the project the service provider will be required to hand over the web based portal to CATHSSETA and migrate the portal and information to CATHSSETA. The service provider will be required to train CATHSSETA nominated staff and end user on the system, provide technical support and maintenance of the portal.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
