1. Background to CATHSSETA

VISION STATEMENT

“A Leader in skills development within our diverse sector”

MISSION STATEMENT

“To facilitate skills development through strategic partnerships for CATHSSETA to contribute to economic growth”

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SPP) supported by skills development programmes serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity.

CATHSSETA’s critical success factors are described as the Key processes that deliver services to the CATHSSETA beneficiaries, i.e. learners and employers. The process is based on the three critical components of the CATHSSETA service delivery Value Chain:

- Facilitation of Learning Interventions. Involves facilitation of all skills development initiatives
- Quality Assurance of Skills Development. Involves accreditation of skills development facilitators, verification of learners, and development of occupational qualifications
- Employer engagements. Involves the receipt of levies and payments of grants.

The importance of the three areas are the points of integration between them.

2. Overall objective

The objective of this bid is to invite and find a suitably qualified service provider to submit proposals for the provision of leased or outright purchase of office space 250m² to 280m² for the CATHSSETA offices in Limpopo Region. The leasing option will be for a period of thirty two months (32).

3. Contract period

32 Months

4. Indication if the tender will be evaluated on functionality as well as minimum acceptable qualifying score

Yes the bid will be evaluated on functionality and bidders require a minimum of **70 out of 100** points allocated for functionality in order to proceed to the BBBEE and Price stage. Bidders will be evaluated in terms of the minimum compliance requirements. Bidders who do not fulfill all the minimum compliance requirements or do not submit the required documents will be disqualified. (Those who fulfill all mandatory requirements or have submitted the required documents will be further evaluated on critical requirements).

5. Indication if the bid will be evaluated related to local production and contents as well as the minimum thresholds applicable to local production and contents

6. Detailed scope of services to be rendered by the service provider

Cathsseta require a suitably qualified service provider to submit proposals for the provision of leased office space (250m² to 280m²) for the CATHSSETA for a period of thirty-two (32) months in Limpopo Region.

The proposal submitted by bidders must include the following CATHSSETA requirements and CATHSSETA will not incur any fit-out costs;

The office space must be within the city of Polokwane

- i. Ensure Close proximity to public transportation;
- ii. The actual building size proposed (not the total size of the property) must be within a range of 250m² to 280m²; The requirements for site accessibility include:
- iii. The building should allow for comfortable entrance / exit to and from the building by staff, clients and service providers;
- iv. The building must make provision for access control which must be accessible to both staff and suppliers; and
- v. The building should have access for people with special needs/ disability

General Requirements

- vi. The building must be an existing building (complete built structure).
- vii. Approximately between 250m² and 280m² Gross Lettable Area (GLA).
- viii. Exterior signage must be allowable.
- ix. Building insurance is the responsibility of the landlord for the option of leasing

- x. Existing wheel chair access to the building (eg. wheel chair ramp).
- xi. Minimum 7 secure on-site parking that must be available in accordance with municipal by-laws. Should also have adequate Visitors parking. Confirmation of which should be included in the proposal.

Building services

- xii. The building must make provision for goods and passengers lifts (if applicable).
- xiii. Office space should have built-in kitchen
- xiv. Dedicated ablution facilities accommodating approximately 7+ employees and visitors, including facilities for the physically disabled must be available
- xv. The accommodation must provide lighting as per building regulation.
- xvi. The office accommodation must be fully air-conditioned and ventilated.
- xvii. Uninterrupted power supply (UPS) and back-up generator power supply must be available in the event of power failure for the entire building.
- xviii. The space(s) on offer must have its own electric distribution board(s).
- xix. The accommodation must have existing fire detection and prevention services.
- xx. A floor plan of the building drawn to scale is required.
- xxi. Provision of one IT server room and one file room.
- xxii. The lease offered must be for **thirty-two (32) months** with the option to extend.
- xxiii. The lease offered must provide a termination option.
- xxiv. The lease offered must provide CATHSSETA with right of first refusal.

- xxv. The lease offered must indicate the tenant installation allowance.
- xxvi. The lease offered must provide an option for building maintenance by the lessor / landlord as part of the lease.
- xxvii. The lease contract should be signed with the owner of the building/ landlord not an agency or third party.

If the bidder suggests certain changes to the General conditions of contract or the special conditions of contract, the proposed changes will be evaluated and if acceptable by CATHSSETA such suggested changes may be included into the contract as special conditions of contract. If the suggested changes are unacceptable the General conditions of contract and the special conditions of contract will stand. The potential bidder will then have to decide to abide by the decision or to withdraw its bid proposal.

If any clarity needs to be obtained for evaluation purposes CATHSSETA may require the potential service provider to substantiate certain information, or to allow officials to undertake a financial/ physical inspection to assure that capacity and ability is proven.

Supporting documentation should be attached as annexures and cross-referenced to the appropriate section of the bid.

Please note that the scope of services as indicated in this TOR reflects CATHSSETA true requirements and once the contract is signed amendments to the contract will only be allowed in exceptional circumstances. Please ensure that your costing is based on the scope of services to be rendered.

Disclaimer

Whilst CATHSSETA is issuing this RFP in good faith, it reserves the right to cancel the selection process and reserves the right not to select any of the respondents to this RFP. CATHSSETA also reserves the right to negotiate cost of the projects and negotiate an acceptable solution with one or more potential providers.

The SETA reserves the right not to appoint a service provider and is also not obliged to provide reasons for the rejection of any proposal. CATHSSETA reserves the right to:

- (8) A person must not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for, unless the intended sub-contractor is an exempted micro enterprise that has the capability and ability to execute the sub-contract.

Post contract (Regulation 11.9)

- (9) A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the sub-contract.

18. Additional Bid requirements if an consortium/ joint venture/ trusts is submitting a bid proposal

The name of the entity with whom the CATHSETA will ultimately contract and who will be responsible for the overall service delivery. This is required in all instances and is particularly relevant in a consortium.

Consortiums must submit a Copy of Registration Documents with the Registrar of Companies (CIPS)

All members of a consortium or joint venture must provide an original SARS tax clearance certificate.

A trust, consortium or joint venture will qualify for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

Regarding joint ventures the joint venture agreement between the different suppliers must be provided clearly indicating the role and responsibilities of each supplier towards the contract.

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- 4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
