1. Background to CATHSSETA

VISION STATEMENT

“A Leader in skills development within our diverse sector”

MISSION STATEMENT

“To facilitate skills development through strategic partnerships for CATHSSETA to contribute to economic growth”

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SPP) supported by skills development Programmess serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality.
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity.

CATHSSETA’s critical success factors are described as the Key processes that deliver services to the CATHSSETA beneficiaries, i.e. learners and employers. The process is based on the three critical components of the CATHSSETA service delivery Value Chain:

- Facilitation of Learning Interventions. Involves facilitation of all skills development initiatives
- Quality Assurance of Skills Development. Involves accreditation of skills development facilitators, verification of learners, and development of occupational qualifications
- Employer engagements. Involves the receipt of levies and payments of grants.

The importance of the three areas are the points of integration between them.

Problem statement

CATHSSETA mandate is to facilitate skills development within the 6 sub sectors. One of the key learning Programmess delivered by CATHSSETA is the work intergrated learning and Internship Programmess. These Programmess seek to expose learners to the workplace and ensure that practical experience is gained. Over the last few years, CATHSSETA has observed that learners placed in the workplace do not have workplace etiquette and they do not know how to conduct themselves in the workplaces. This amongst others, is part of reason learners do not complete Internship and Work Intergrated Learning Programmess. The non completion of learners in learning Programmess affects performance of the SETA.

2. Overall objective

CATHSSETA seeks the services of a service provider to:

- Conduct a feasibility study on the need for work readiness Programmess in the CATHSSETA sub sectors.
- Develop models for work readiness Programmess
- Develop Programmess and course material for work readiness Programmess
- Develop a strategy for maximum exposure of the Programmess

6. Detailed scope of services to be rendered by the service provider

CATHSSETA seeks the services of a service provider to conduct a feasibility study on the need for work readiness Programmess in the CATHSSETA sub sectors.

- The feasibility study must identify current Programmess in the market, the similarities and differences as well as best practice in the industry at the moment.
- The feasibility study should further identify models that can suit CATHSSETA sub sectors taking into consideration the needs of the industry and the diversity of the sub sectors
- The service provider will be required to develop a CATHSSETA specific model that will suit the sub sectors
- The service provider will be required to develop the following;
 - programmes outlined;
 - work readiness courses outlined; and
 - learning material.
- The model that will be developed must incorporate partnership within the industry. It is envisaged that part of the programme will be workplace exposure and talks with industry leaders.
- The workplace exposure should incorporate learners visiting and being exposed to practical day to day work environment.
- The feasibility study should also determine if the programmes must be sector specific or whether it must be value chain based programmes in line with the diversity of the CATHSSETA sub sectors.

- The feasibility study should identify the number of learners who need to be put through the programmes annually per sector.
- The study should advise CATHSSETA how to position the programmes in order to ensure that there is maximum exposure. The recommendation should further provide a model and strategy that will ensure maximum exposure.
- The service provider should ensure that the approach covers the provincial spread and priority sub sectors per province.
- At the end of the programmes it is envisaged that the participating learners will be ambassadors of CATHSSETA.

No verbal requests for information or clarification will be accepted. Answers to queries shall be posted to the CATHSSETA web site www.CATHSSETA.org.za (under Bids), and will therefore be in the public domain.

All documentation and responses will be supplied and exchanged utilising standard Microsoft Office (Word, Excel and PowerPoint) products.

Any attempt to gain information in a manner deemed to be fraudulent or disadvantageous to other respondents or any attempt to influence the outcome of the response evaluation will result in immediate disqualification from the bid process.

The SBD 1 "Invitation to Bid" must be completed and attached as the front sheet to the response and any other separate submissions.

If the bidder suggests certain changes to the General conditions of contract or the special conditions of contract, the proposed changes will be evaluated and if acceptable by CATHSSETA such suggested changes may be included into the contract as special conditions of contract. If the suggested changes are unacceptable the General conditions of contract and the special conditions of contract will stand. The potential bidder will then have to decide to abide by the decision or to withdraw its bid proposal.

If any clarity needs to be obtained for evaluation purposes CATHSSETA may require the potential service provider to substantiate certain information, or to allow officials to undertake a financial/ physical inspection to assure that capacity and ability is proven.

Supporting documentation should be attached as annexures and cross-referenced to the appropriate section of the bid.

Please note that the scope of services as indicated in this TOR reflects CATHSSETA true requirements and once the contract is signed amendments to the contract will only be allowed in exceptional circumstances. Please ensure that your costing is based on the scope of services to be rendered.

Disclaimer

Whilst CATHSSETA is issuing this RFP in good faith, it reserves the right to cancel the selection process and reserves the right not to select any of the respondents to this RFP. CATHSSETA also reserves the right to negotiate cost of the projects and negotiate an acceptable solution with one or more potential providers.

The SETA reserves the right not to appoint a service provider and is also not obliged to provide reasons for the rejection of any proposal. CATHSSETA reserves the right to:

- Award contract or any part thereof to one or more Service Providers;
- Reject all bids;
- Consider any bids that may not conform to any aspect of the bidding requirements;

- Decline to consider any bids that do not conform to any aspect of the bidding requirements;
- Request further information from any Service Provider after the closing date;
- Cancel this tender or any part thereof at any time.

Take note that if **subcontractors** are going to be utilized the following B-BBEE rules will be applicable for the allocation of B-BBEE points:

Pre-contract (Regulation 11.8)

- (8) A person must not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for, unless the intended sub-contractor is an exempted micro enterprise that has the capability and ability to execute the sub-contract.

Post contract (Regulation 11.9)

- (9) A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the sub-contract.

20. Additional Bid requirements if an consortium/ joint venture/ trusts is submitting a bid proposal

A trust, consortium or joint venture will qualify for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

Regarding joint ventures the joint venture agreement between the different suppliers must be provided clearly indicating the role and responsibilities of each supplier towards the contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
