1. BACKGROUND TO CATHSSETA

The Skills Development Act (No 97 of 1998) (SDA) makes provision for the establishment of Sector Education and Training Authorities (SETAs) for each national economic sector and thereby aims to develop the skills of the South African workforce by increasing the investment in education and training in the labour market; and encouraging employers to play a meaningful role in developing employees, particularly the previously disadvantaged. The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA) was established through the SDA, to research and establish nationally recognised Sector Skills Plan (SSP) supported by skills development programmes serving the interest of the following sectors:

- Culture, Arts and Heritage
- Tourism and Travel Services
- Hospitality
- Gaming and Lotteries
- Conservation; and
- Sport, Recreation and Fitness

These sectors are diverse and unique and they play a significant role not only in the economy, but also in the broader quest for social cohesion and formulation of a unique South African national identity. The National Treasury Instruction No. 05 of 2019/20 requires national and provincial institutions to implement the Revised Framework for Strategic Plans and Annual Performance Plans (2019).

- **The Sector Skills Plan**

The SSP is prepared by the SETA in accordance with the guidelines included in the National Skills Development Plan (NSDP), as well as the DHET SSP guidelines and requirements. The main purpose of the SSP is to analyse the demand and supply of skills to the sector and, on the basis of this analysis, determine the skills needs and the skills development priorities for the sector. The plan highlights strategies for addressing skills needs and intervention priorities.

- **The Strategic Plan**



In order for CATHSSETA to ensure the attainment of its development outcomes and set out high-level service delivery commitments and targets, a planning process needs to be adopted to develop a sound SP. The SP is used by the Accounting Authority to monitor and oversee the organisation's performance during the 5 year licensing period. The SP reflects a commitment to the realisation of the full mandate and strategic intent of the entity.

- **The Annual Performance Plan**

The APP highlights CATHSSETA's development outcomes by placing emphasis on targets aligned to the outcomes of the NSDP. Parameters are set for the achievement of targets as set in the Service Level Agreement (SLA) with DHET. The APP is not only utilised by the Accounting Authority to monitor the organisation's annual performance, but the DHET as well places emphasis on SETA performance. Performance against the APP is monitored on a quarterly basis to ensure service delivery.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
