Applications are invited from suitably qualified, experienced independent individuals whose candidacy will promote representivity to be considered for appointment to serve on the Audit and Risk Committee. The Audit and Risk Committee is an independent Committee established in terms of Section 77 of the PFMA to review the internal controls, governance, and risk management within the institution.

Requirements: An LLB degree plus admission as a legal practitioner. Admitted Attorney with a minimum of five years in practice post-admission.

Experience: A minimum of five (5) years of traceable experience serving on Audit Committees or other governance structures in public institutions is required.
