
Applications are invited from suitably qualified, experienced independent individuals whose candidacy will promote representivity to be considered for appointment to serve on the Audit and Risk Committee. The Audit and Risk Committee is an independent Committee established in terms of Section 77 of the PFMA to review the internal controls, governance, and risk management within the institution.

Requirements: A bachelor's degree in the field of accounting or finance plus registration as a Chartered Accountant (CA) under the South African Institute of Chartered Accountants (SAICA) or Management Accountant under the Chartered Institute of Management Accounts (CIMA).

Experience: A minimum of five (5) years of traceable experience both working at the managerial level and serving on Audit Committees or other governance structures in public institutions is required. Knowledge and understanding of the Sector Education and Training Authority (SETA) environment and an understanding of the regulatory framework governing this sector will be an advantage.

Remuneration: The members of the Audit and Risk Committee are remunerated at rates determined by the National Treasury. Employees of National, Provincial and Local Government or Institutions, Agencies and Entities of Government serving on the Audit and Risk Committee are not entitled to additional remuneration.
